The Motion to Waive was not agreed to by a vote of **50-50**. The point of order is sustained and the amendment falls.

**H.R. 3364 (Countering America's Adversaries through Sanctions Act)**. The bill was read for a third time. **Final Passage**. Yeas and Nays ordered. The bill was passed by a vote of **98-2**.

### **H.R. 1628 (American Health Care Act of 2017).**

H.R.3298 (Wounded Officers Recovery Act). Flake amendment agreed to by Unanimous Consent. The bill, as amended, was agreed to by Unanimous Consent.
